



MEMORANDUM OF UNDERSTANDING

Between

Indian Institute of Tourism and Travel Management (IITTM)

(A Ministry of Tourism, Government of India Organization)

And

Bundelkhand University, Jhansi

This Memorandum of Understanding (MoU) is made on this [Date] between Indian Institute of Tourism and Travel Management (IITTM), having its headquarters at Gwalior, Madhya Pradesh, India (hereinafter referred to as "IITTM"), and Bundelkhand University, Jhansi, Uttar Pradesh, India (hereinafter referred to as "BU"), collectively referred to as the "Parties."

- **1.** The purpose of this MoU is to establish a framework for collaboration between IITTM and BU in the areas of academic cooperation, research, training, student and staff exchange, and other related activities of mutual interest.
- 2. Areas of CollaborationThe Parties agree to collaborate in the following areas:
 - Joint academic programs including certificate, diploma, and degree courses.
 - Research projects and publications in areas of mutual interest.
 - Organization of seminars, conferences, workshops, and training programs.
 - Student and faculty exchange programs.
 - Development of joint study materials, curriculum design, and academic resources.
 - Internships, field visits, and project-based learning.
 - Any other academic and research activities mutually agreed upon.
- **3. Implementation Mechanism**The Parties agree to form a Joint Coordination Committee (JCC) comprising representatives from both institutions to oversee the implementation of collaborative activities. The JCC will meet periodically to review the progress of activities and resolve any operational issues.

A. Financial Arrangements Each Party will bear its own expenses incurred in the course of Archaboration unless otherwise agreed upon in writing. Specific projects or programs may have subgrave financial terms agreed upon through supplementary agreements.

Property Rights Any intellectual property developed jointly will be subject to separate agreement, which will outline the rights, ownership, and usage of such ntellectual property.

- 6. Confidentiality Both Parties agree to maintain confidentiality regarding any proprietary or sensitive information shared during the course of the collaboration.
- 7. Duration and Termination This MoU will remain in effect for a period of five (5) years from the date of signing, unless terminated earlier by either Party with a written notice of three (3) months. The MoU may be renewed or amended by mutual consent.
- 8. Dispute Resolution Any disputes arising out of the implementation of this MoU will be resolved amicably through mutual discussions. If not resolved, the matter will be referred to the heads of both institutions for final resolution.
- 9. General Provisions This MoU does not create any legal or financial obligations between the Parties. The MoU serves as an expression of intent to promote cooperation and collaboration.
