[06] This study explores the relationship between economic growth and the tourism industry using the Ordinary Least Squares (OLS) method and time series data spanning from 2005 to 2023. The tourism industry is characterized as dynamic and promising, with increasing investment globally. Competitiveness in attracting foreign tourists has intensified, driven by the industry's significant role in national economies, generating foreign exchange revenue, and job creation. Industrialized nations are particularly invested in tourism promotion, recognizing its economic importance and sustainability. However, the analysis reveals a weak positive relationship between economic growth and tourism. Although foreign tourism receipts contribute to economic growth, their impact appears limited. Overall, the findings suggest that while tourism plays a role in economic advancement, its influence on growth rates may be less significant than previously assumed.
