for the purpose of achieving the various aims and objectives relating to the events organized by **Gauri Foundation (NGO) & DSW**

### PURPOSE:

The purpose of this Memorandum is to provide the framework for any future binding contract between **GAURI FOUNDATION (NGO)** and **Office of Dean Students Welfare**, regarding the collaborative organization of **Gauri Foundation (NGO)** and **DSW** for academic and social welfare events and activities.

**Gauri Foundation (NGO)** primarily focus on performing Fundamental Duties of the Nation by organizing activities regarding welfare of students, which includes conduction of Quiz, Seminars related to National development, organizing free health camps and other activities for the welfare of students and youth.

**Bundelkhand University** came into existence on August 26, 1975, vide Government of Uttar Pradesh Notification No. 10/15-60/74 under the provision of the U.P. Universities Act. However, though belonging to the younger generation of the Indian Universities, the Bundelkhand University

### GENERAL:

Both the parties agree to the following:

Use respective logos as event partners in their events.
- Invite senior leadership to their events.
- Allot time to make five-minute presentations at their events

This agreement can only be amended or modified by written agreement signed by both parties.

- Neither of the parties to this agreement may assign their rights or benefits under this agreement without prior written consent from the other party.

- **Gauri Foundation** is obliged to Promote National Unity and International peace and amity. **Gauri Foundation** work for the cause of enforcement of prohibition and initiate people's movement against smoking, alcoholism and drug abuse.
- **Gauri Foundation** imparts free education to the needful. **Gauri Foundation** work for the promotion of Sports and healthcare activities.

### CONFIDENTIALITY OF AGREEMENT AND INFORMATION

Each Party agrees to keep this Agreement and the contents thereof strictly confidential and agrees, for itself and its officers, employees and representatives,



to keep confidential and not make any unauthorized use of any confidential or proprietary information of the other Party disclosed to such Party in and during the performance of this Agreement, including documents, records and information (hereinafter the "Confidential Information").

**DURATION**

This MOU is at-will and may be modified by mutual consent of authorized officials from GAURI FOUNDATION (NGO) and Bundelkhand University, Jhansi. This MOU shall become effective upon signature by the authorized officials from GAURI FOUNDATION (NGO) and DSW and will remain in effect until modified or terminated by any one of the partners by mutual consent.
