The University aims to become a world-class institution by tapping human potential to lead the country in changing national, regional and global scenario.

Mission

To impart quality vocational and scientific education through basic and applied research to foster an ambience of intellectual excitement conducive to discovery of new knowledge; to improve the quality and value of human irrespective of gender, caste, nationality and religion.

6.2 Does the Institution has a management Information System (MIS)

The University has cabled as well wifi campus wide networking which as hundred mpbs speed and all offices/departments/cells/centres/directorate are well connected through LAN. However, the University intends to shift towards intranet system of office working in the near future.

The University has initiated to introduce various ERP modules for efficient MIS support in academic and administrative activities.

The grievances, Biometric attendance, file tracking, student feedback, RTI, payroll etc. are being implemented.

6.3 Quality improvement strategies adopted by the institution for each of the following

6.3.1 Curriculum Development

Invariably professional and practitioner are nominated on Board of Studies and Research of University Teaching Departments so as to seek their advice for bridging the gap between theory and practice. This process intends to facilitate the University to enriched and job orientated both in terms of contends and intent.

In the Last five years, the University has undertaken several measures, which can be labelled as best practices in curricular aspects:

The University entered into MOU with leading and renowned organisations to provide technical, conceptual and domain specific training to the students of professional and allied courses.

The University has very liberally promoted the adoption of UGC-sponsored

add-on courses which include environmental education, Computer Education, Ethical Education, human rights and Communication skills.

The University has adopted the semester system in place of the annual system of examination for more effective organization of teaching and evaluation. This includes the introduction of internal assessment on the triple criteria of attendance, testing and assignments/classroom performance.

The syllabi are revised at least once every two years in view of the feedback received from various sources and the changing requirements.

6.3.2 **Teaching and Learning**

The teaching and learning pedagogy consists of lecturing, case study, role playing, experimentation, group discussions, speech, assignment-presentations and via-voce.

The University is in process of implementing modified Credit Based System, therefore, the teaching learning become a continuous process for assessment and evaluation of students admitted in different programmes. All this make this University unique in terms of teaching and learning process.

- The faculty is encouraged to use ICT modules and audio visual aids for effective and interactive teaching and learning
- The University has been recognised as Nodal centre by the Ministry of HRD for its mission National Mission on Education through ICT and NPTEL online self learning material is available on the university website for the use of students on campus and affiliated colleges.
- Most of the faculty has been trained in the use of computers, internet and audio visual aids.
- Modern educational technologies in teaching, such as multimedia teaching have been strengthened. Almost all the departments have been provided with computers and internet facilities.

6.3.3 **Examination and Evaluation**

As per the norms of the University there is a mechanism of 70 :30, in which 70% evaluation is done through major examinations on semester basis and 30% based on continuous evaluation in the form of mid semester test, minor test, classroom seminars, class room quizzes, home assignments, class attendance, viva-voce, field visit etc.

The University has introduced on-Screen Evaluation in some of the departments i.e. Education and Engineering as first phase.

The University has pioneered to digitise all the old examination records for the reference of the students, alumni and verification agencies online.

Scanning of the awards from Answer sheet given by the examiners after evaluating the answer books and finally preparation and declaration of the result with the help of scanner and software.

Surveillance cameras are being installed in all the examination centres for better transparency.

Merit List declared by University is also available on University website

News and Press Release regarding Examination is also available on University website.

To strengthen the invigilation at examination centres, more Flying Squads are sent every session. This has helped in preventing the use of any kind of unfair means to greater extent.

6.3.4 **Research and Development**

The faculty members are encouraged to have individual research projects, intra, University inter institutional research projects funded by different national and international agencies. The faculty members are also encouraged to participate in national and international conferences, seminars, symposia, workshop etc. to have the exposure of latest research developments in their concerned fields and use the same in their teaching and research. The faculty members are given grants to in the form of minor research projects at the University level.

The University has developed an Innovation Centre to house the major equipments. Principal investigators are given full financial autonomy for smooth running of the project.

To ensure quality research the University has conducted the Common Entrance Test for admission in Ph.D. The ordinance and syllabi for the Coursework as per the revised norms of UGC has been developed.

MOUs with leading research organisations have been entered to facilitate the faculty and research scholars undertake research in renowned institutions with best state of the art research equipments.

6.3.5 **Library, ICT and physical infrastructure/ instrumentation**

The University has a central library, which is equipped with state of the art ICT facility and more than 92000 books of different fields. The University subscribes online journals from the major international publishers.

The reading area of the University is open around the clock for students.

The University has a Innovation Centre major equipments required for quality research in basic and applied sciences.

Further, the University has 186 acres of total area of which is fully developed that includes 24 Teaching Blocks, three boys hostels, four girls hostels, dedicated indoor stadium, University Health Centre, shopping complex, Post Office, Bank, Administrative Block etc.

The University has its own Auditorium with three mini seminar halls to run parallel session with a total seating capacity of more than 1000. The University has its play grounds.

The University aims to make best use of ICT tools in teaching learning and evaluation.

The Biometric attendance and surveillance system is being installed.

The science labs and computer labs are being equipped with latest technology.

The campus is being Wi Fi enabled in phased manner. CCTV cameras are also installed at many places. The Central library have been totally computerized.

The University has more than 700 computers installed in offices and computer labs with broadband facility.

The Smart Class Rooms have been developed.

The website has links with leading institutions for provision of self learning material.

The website has links with NKN.

The library has well equipped reference section provided with internet, photocopying and other facilities.

6.3.6 Human Resource Management

The human resource management policies of this University are in compliance with UGC regulations and State Govt. guidelines. The appointment and promotions are made in transparent manner and as per defined and notified criterion. The organizational hierarchy of the University is well defined in which the job profile and job description in each and every office is clear to all stakeholders. The governance and administration of the University is professional and also as per the spirit of the Act and Statutes which results into higher level of satisfaction specially amongst the students and scholars and staff of the University.

The faculty is provided opportunities to organize and attend seminars and conferences at national and international level. Grant is provided to fund the travel partially.

Faculty Development programmes are organized to equip the teachers with

latest academic and research tools.

6.3.7 Faculty and Staff Recruitment

There is a established and transparent procedure for the faculty and staff recruitment in the University, the UGC regulations for staff recruitment are followed in tune with the guidelines.

For Self Finance Scheme positions, budgetary allocations are made in the annual budget and recruitment is made as per the set procedure approved by Competent Bodies.

6.3.8 Industry Interaction / Collaboration

The University strongly advocate and promotes university industry linkage for the purpose of solving the technical problems of the industry and creating skilled human resource. The industry people are on Board of Studies of different departments so that their needs can be incorporated accordingly in course curricula and students can be prepared as per market requirement.

The continuous interaction with the Industries is maintained through the Placement cell, by inviting the industry people in the departments, in various conferences, in meetings where we feel that their experience will be helpful to us.

Also from many of the departments students are sent to the industry for projects and hand on experience of the industrial processes.

The faculty is encouraged to do the projects in collaboration with the industry.

6.3.9 Admission of Students

Admissions of students are done once in a year on the basis of national level entrance test. The reservation policy of the State Govt. is followed in total as notified by State Govt. from time to time.

The admissions in professional streams are made through UPSEAT examination and in remaining PG courses through the Common Entrance Test conducted by the University.

vii. Sophisticated instruments centre established in the past to cater the research needs of science and engineering departments has been further strengthened to have more research facilities. Wi-Fi facilities in some hostels


